#### **Previous Progress Update**

- During the previous meeting the group discussed the draft definition for mobile food units which was crafted by the Ad Hoc Group. With some additional modifications the group motioned the language to straw ballot with this TG.
- That straw ballot yielded a vote of 12:0:0 (Yes: No: Abstain) with 0 comments.

#### Previous Progress Update (December 19, 2023)

- During the previous meeting the group decided to first focus on Scope, Title, and Purpose of the Standard before continuing efforts on the content.
- These sections were recently open for review and comment via straw ballot which yielded a vote of 9:0:0 (Yes: No: Abstain) with 4 comments.

### Previous Progress Update (July 18, 2023)

- Approximately 20 years ago NSF began the development of a new Food Equipment Standard called: NSF/ANSI 174 Mobile Food Units, to be in accordance with ANSI (American National Standards Institute) approved procedures.
- The intent was to create a standard to set minimum public health and sanitation requirements for the design and construction of mobile food units. Mobile food units would include trailers and motorized vehicles that may prepare and/or serve food to a wide array of consumers.
- From 2002 to 2006 the Task Group assigned this created and began balloting language.
- Although a generally robust Standard was largely created, the process was not completed due to other urgent unrelated public health issues affecting other Food Equipment Standards such that the group focused energies elsewhere.
- During the 2022 Face-to-Face meeting the group agreed to resurrect work on this project
